



- Our students will soon take the NOCTI exam. Please encourage your student to do their best and take pride in the skills and knowledge they have worked hard to develop. Your support and encouragement can help them perform with confidence. Thank you for supporting their success. (see attached flyer, below)
- NOCTI Performance Test – Wednesday, April 29th

All 12th-grade students—*except those in the Precision Machine Technology program*—are required to report to CCTI for NOCTI testing.

Arrival: Students should arrive between 7:30 AM and 7:45 AM and enter the building through the cafeteria doors. A light breakfast will be provided. Students will be escorted to their technical areas in groups.

Transportation: There will be no district transportation provided on Wednesday, April 29th. Seniors are responsible for arranging their own transportation. Options include:

- Driving themselves
- Riding with another student (*a permission slip is required*)
- Being dropped off and picked up by a parent or guardian

CCTI staff will provide transportation for students who are unable to secure a ride. These arrangements will be finalized by Friday, April 24th.

Parking: Student parking will be available on the west side of the front parking lot (near the Main Office). Evaluators will park on the east side of the lot (in front of the Cafeteria and Dining Room).

Note: All underclassmen (grades 9, 10, and 11) and students in the Precision Machine Technology program will have the day off.

- Senior parents/guardians: Please send your Breakfast with your Senior permission slip form in to Mrs. Kohutka by Friday, May 4, 2026.
- Attention Seniors:  
It is time for Seniors to apply for their High School Hero Red Cord (Certificate).  
All applications for the Red Cords need to be completed and submitted by April 30th.  
Students will NOT automatically receive the cord/certificate they must apply to receive them.

As a reminder – here are the general guidelines for applying for the Red Cords:

1. Students must have donated four (4) times over their high school career.
2. Students must have volunteered four (4) separate times at four different blood drives over the course of their high school career.

Additional notes:

Please:

1. Make sure you have donated or volunteered. You cannot combine donating and volunteering to make up the 4 events.
2. Be sure to have the dates and the list of activities you performed.
  - *Example: I donated on 1/31/25, 4/12/25, 10/24/25, 2/1/26 (donations do not need to be completed at the school to count)*
  - *Example: I volunteered with the blood drives on 12/4/25, 10/18/25, 12/13/25, 3/20/25*

Remember:

- Do not submit your application multiple times. A pop-up message will appear on the screen when you have successfully completed your application. Duplicate applications create extra work for MKBC employees and slow down the processing time.
  - You will only receive an email if there is a problem with your application. No email = good news.

- Policy reminder: Students are not permitted to drive to CCTI unless they have a valid parking permit issued by Officer Woods. Students are also not permitted to drive to and from school with other students who have parking permits unless they live in the same household as the student with the permit. Students who violate this policy will face disciplinary consequences.

- Student dress code reminder: According to our student handbook, pajama tops or bottoms are not permitted to be worn to school.
- Information for Seniors from the Pennsylvania Higher Education Assistance Agency:

With the 2026-27 Free Application for Federal Student Aid (FAFSA®) opening last month, the Pennsylvania Higher Education Assistance Agency (PHEAA) has been working to prepare our PA State Grant processing system, GrantUs<sup>SM</sup> for the upcoming award year. We are now pleased to announce that processing for the 2026-27 PA State Grant Program has been initiated.

- New this year, a pre-screening methodology allows us to perform immediate review of the student's FAFSA data to determine whether the student meets initial PA State Grant applicant criteria through pre-eligibility checks (for example submitted a complete FAFSA, is a PA resident, not in default, etc.) If the student's FAFSA data passes these initial checks the student's record will be created in GrantUS.
- An account activation notice will be sent after the student's FAFSA data successfully passes the pre-screening process if the student does not have an existing account.

- Activation notices will be sent from [noreply@grantus.pheaa.org](mailto:noreply@grantus.pheaa.org).
  - Activation notices are time sensitive and will expire after 5 days. If the student does not access the link before it expires, they can use Forgot Password on the GrantUS log in page.
  - Students that have an existing account are not required to make a new account but instead should log in with their existing credentials. Students can select Forgot Password on the login page if they do not remember their password.
- 
- Please remember that attendance is extremely important for students at CCTI and eventually in the working world. Poor attendance and truancy at CCTI may result in fines, and loss of privileges. Due to excessive absenteeism (including days absent accompanied by a parent note), students may also experience loss of credit for the courses taken during the school year (20 Day Policy).
  - Parents, please ask your student to show you their Google Classroom so you can see what students are working on in their classes. Also, if a student is absent, he/she is expected to check Google Classroom to retrieve and complete assignments to avoid falling behind.
  - After school tutoring and clubs and activities are available. Please see Ms. Hyjurick in room 311 for more information about after-school tutoring or see Ms. Benyo in room 203 for more information about staying after school to attend a club/activity meeting. Please consider using our free tutoring resource to maintain a positive grade point average and/or for extra support. Please consider getting involved in a CCTI club/activity.

- Please be aware that our school has installed vape detectors in bathrooms. These detectors are in place to promote a healthy environment and discourage vaping on campus.

### Key Points to Keep in Mind:

- Detection: The detectors can identify vaping in real-time, meaning that if you vape in the bathrooms, you will be caught. Unfortunately, some students have already been caught as a result of the detectors.
  - Consequences: If detected, there will be disciplinary actions, including out-of-school suspension, expulsion, and referral to law enforcement officials (refer to JOC Policy 227 – Controlled Substances/Paraphernalia/Mood Altering Substances, Chemical Use, Abuse, and Dependency Policy in the Student/Parent Handbook, and JOC Policy 233 – Suspension and Expulsion – all are on our website).
  - Health Matters: Remember that vaping can pose significant health risks, and it's important to prioritize your well-being.
- Parents, please help your student get to school on time by dropping them off no later than 7:40 a.m. This will allow students to get to their locker and get ready to start their day at 7:45. Thank you for your cooperation.
